Motorways

Project “**Design – Construction – Self-Financing and Exploitation of the Elefsina – Stavros – Spata A/P Motorway and Western Peripheral Motorway**” (**ATTIKI ODOS Motorway**): Legal counsel to the candidate and concessionaire from the tender procedure until today.
